The Barrhaven Business Improvement Area graffiti removal program, in partnership with Go Green, cleans tags from all commercial buildings through a financially supported, graffiti removal and deterrence initiative. Allowing graffiti to spread in the community leaves the impression that nobody cares or is in control of this issue. Continual and prompt removal of graffiti and tags sends a strong message that vandalism is not tolerated, and that the business community intends to address this issue in a very definite way.

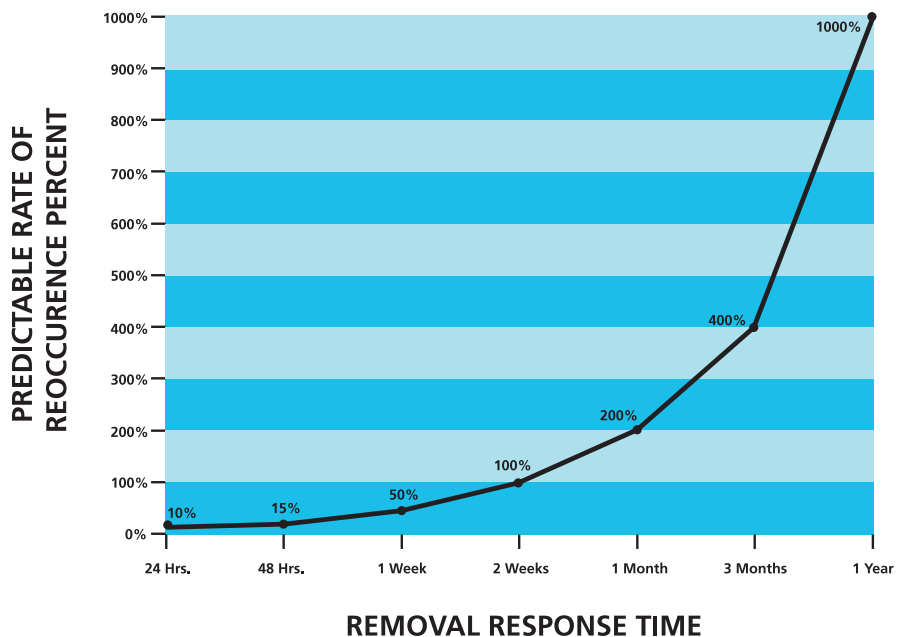
All property owners in the BIA must return a signed waiver agreeing to participate in this program. This program is of great benefit to you; however, we need your permission to perform any removal on your property before any positive work can begin.

Under City By-Law, property owners are responsible for the removal of graffiti from their own property. We are offering assistance to aggressively address this issue. By working together to remove graffiti and keep it off, we are saying that we don't accept vandalism. Please complete the attached waiver and return it to us so we can add you to the weekly patrol.
